

Membership Type Conditions

Overseas qualified applicants

Applying for Osteopathy Australia membership does not entitle you to practise osteopathy in Australia. The [Australian Osteopathic Accreditation Council \(AOAC\)](#) carries out assessments of the skills and qualifications held by overseas trained osteopaths on behalf of the [Osteopathy Board of Australia \(OBA\)](#).

ACADEMIC

APPLICABLE CONDITIONS

- Currently qualified and registered as an osteopath in Australia
- Current and sufficient Professional Indemnity insurance
- Committed to the principles of Continuing Professional Development
- Must complete annual CPD requirements of Osteopathy Board of Australia (OBA)
- Applicants must be in ongoing academic employment for at least 0.6 FTEii (e.g. at least 3 days per week, at a tertiary institution in Australia)
- \$165 join fee applies to a new or re-joining member application
- Osteopathy Australia membership can be cancelled during a membership cycle, but no refunds are provided
- On application for membership with Osteopathy Australia, you:
 - declare all information submitted to be true and correct
 - accept that membership does not imply a right to practise in Australia

Academic membership is restricted to those working at least 0.6 FTE as an academic at a tertiary institution in Australia

iiFTE – Full Time Equivalent is hours actually worked divided by the number of normal hours worked by a full-time academic staff member and does not apply to casual work or temporary work over a short period of time

FULL

APPLICABLE CONDITIONS

- Currently qualified and registered as an osteopath in Australia
- Current and sufficient Professional Indemnity insurance
- Committed to the principles of Continuing Professional Development
- Applicants must complete annual CPD requirements of Osteopathy Board of Australia (OBA)
- \$165 join fee applies to a new or re-joining member application
- Osteopathy Australia Membership can be cancelled during a membership cycle, but no refunds are provided
- On application for membership with Osteopathy Australia, you:
 - declare all information submitted to be true and correct
 - accept that membership does not imply a right to practise in Australia

GRADUATE

APPLICABLE CONDITIONS

- Currently qualified and registered as an osteopath in Australia
- Current and sufficient Professional Indemnity Insurance
- Committed to the principles of Continuing Professional Development
- Completion of annual Continuing Professional Development requirements
- \$165 join fee applies to a new or re-joining member application.
- Osteopathy Australia membership can be cancelled during a membership cycle, but no refunds are provided
- On application for membership with Osteopathy Australia, you:
 - declare all information submitted to be true and correct
 - accept that membership does not imply a right to practise in Australia

FURTHER CONDITIONS OF GRADUATE MEMBERSHIP

- You are in your first year immediately following graduation from a relevant Australian osteopathic degree
- Join as a Graduate member by **30 June** of the **current** membership cycle
- **To be exempt from the \$165 join fee**, you were previously an Osteopathy Australia Student member **in your final year** and joined by 30 June in the current membership cycle
- A \$165 *join fee* applies if you were not a Student member in your final year of study

FURTHER CONDITIONS OF GRADUATE 1 MEMBERSHIP

- You are in the **first** full 12-month membership cycle following graduation from a relevant degree (after initial Graduate membership type, if applicable)

FURTHER CONDITIONS OF GRADUATE 2 MEMBERSHIP

- You are in the **second** full 12-month membership cycle following graduation from a relevant degree (after the Graduate1 membership cycle, if applicable)

INTERNATIONAL

APPLICABLE CONDITIONS

- You are a qualified osteopath, however, are not domiciled or practising osteopathy in Australia
- For listing on our [Find an Osteo](#) online search tool, you must provide proof of professional insurance and compliance with regulations in country of operation
- HR Service is unavailable on an International membership type
- \$165 join fee applies to a new or re-joining member application
- Osteopathy Australia membership can be cancelled during a membership cycle, but no refunds are provided
- On application for membership with Osteopathy Australia, you:
 - declare all information submitted to be true and correct
 - accept that membership does not imply a right to practise in Australia

NON-PRACTISING

APPLICABLE CONDITIONS

- Currently qualified as an osteopath in Australia
- You may or may not be registered as an osteopath in Australia
- Not practising osteopathy in any capacity, for **min. 6 months within Australia**
- Must provide evidence your current Professional Indemnity insurance status in Australia is **on hold** (i.e. temporary leave of absence) **or authorise** Osteopathy Australia to contact your insurer directly to confirm your insurance status
- The HR Service is unavailable on a Non-Practising membership type.
- No listing on our [Find an Osteo](#) online search tool
- The maximum period a member may be granted the Non-Practising category, is two (2) years. All decisions are at the discretion of the Osteopathy Australia Board
- \$165 join fee applies to a new or re-joining member application
- Osteopathy Australia membership can be cancelled during a membership cycle, but no refunds are provided
- On application for membership with Osteopathy Australia, you declare all information submitted to be true and correct

PART-TIME

APPLICABLE CONDITIONS

- Currently qualified and registered as an osteopath in Australia
- Practising osteopathy, **in any capacity**, up to **16 hours per week max**
- While a Part Time member, agree to work NO more than 16 hours in any given week ⁱ (working over 16 hrs per week requires Full membership)
- Current and sufficient Professional Indemnity Insurance
- Applicants must **provide evidence** of their current part-time PII status in Australia **or authorise** Osteopathy Australia to contact your insurer directly to confirm your *part-time* insurance status
- Part-time discounted Guild Insurance policy only available **in conjunction with** the Part Time membership, restricted to 16 hours or less each week ⁱⁱ
- Committed to the principles of Continuing Professional Development
- Applicants must complete annual CPD requirements of Osteopathy Board of Australia (OBA)
- \$165 join fee applies to a new or re-joining member application
- Osteopathy Australia Membership can be cancelled during a membership cycle, but no refunds are provided
- On application for membership with Osteopathy Australia, you:
 - declare all information submitted to be true and correct
 - accept that membership does not imply a right to practise in Australia

ⁱPart Time Membership is restricted to those working 16 hours or less in any given week; these hours are not cumulative

RETIRED

APPLICABLE CONDITIONS

- Ordinary members may apply to the Osteopathy Australia Board based upon attaining the age of 65 and/or ceasing practice for permanent retirement
- Only previous Osteopathy Australia members can apply for Retired Membership
- Retired member must not practice in any capacity and must demonstrate their non-practising registration on the AHPRA register
- Applicants must provide evidence of cancelled Professional Indemnity insurance and run-off cover; **or authorise** Osteopathy Australia to contact your insurer directly to confirm your insurance status
- No need to re-apply for Retired Membership status once it's been granted Each subsequent renewal will be sent under this category
- No CPD requirements
- No listing on our [Find an Osteo](#) online search tool.
- \$165 join fee applies to a re-joining member application
- Osteopathy Australia membership can be cancelled during a membership cycle, but no refunds are provided
- On application for membership with Osteopathy Australia, you declare all information submitted to be true and correct

STUDENT

APPLICABLE CONDITIONS

- You are currently studying osteopathy in an **Australian** osteopathic university
- Evidence or confirmation you are currently enrolled in in an Australian osteopathic university is required
- You are not currently qualified as an osteopath in Australia
- You are not practising osteopathy in any capacity
- You cannot have a listing on [Find an Osteo](#)
- There are no CPD Requirements
- The HR Service is available to a Student member in their final year of study
